Pursuant to the selection list issued vide No: NGS/MC/20/Final-SEL/NHM/GBPLD-COVID/JGN dated: 11.01.2021, the services of the persons indicated in Annexure-A to this Order are hereby temporarily hired on contract basis as Jr. Grade Nurses on consolidated monthly honorarium of Rs.14,500/- per month under National Health Mission Programme for L.D and G.B.Pant Hospital, Sgr. for a period upto 31.03.2021 which shall be renewable for a further period of one year or till continuation of the Scheme whichever is earlier, subject to satisfactory performance of the candidate/approval of the competent authority.

1. The hired persons from S.No: 01 to 04 shall join in the office of the Medical Superintendent, L.D Hospital, Sgr. and from S. No: 05 to 14 shall join in the office of the Medical Superintendent, G.B.Pant Hospital, Sgr. within a period of 07 days from the date of issuance of this Order, failing which their engagement shall be deemed to have been cancelled ab-initio without any further notice in this behalf and next candidate as per merit will be considered for engagement as Jr. Grade Nurse.
2. The hired persons shall be allowed to join only on production of the following documents:
 - a. Date of Birth Certificate
 - b. Domicile Certificate
 - c. Diploma/Degree Certificate
 - d. Diploma/Degree Certificate (Year wise)
 - e. No Loan certificate from District Employment Exchange and District Industries Department.
 - f. Any other document as required under rules.
3. The temporary engagement of the persons is subject to the outcome of the writ petition, if any pending in the Hon'ble court of Law.
4. The services hired will be purely on temporary basis for a period upto 31.03.2021 or till continuation of the scheme whichever is earlier and will automatically cease/terminate once the scheme is over. It is emphasized that the services are not being hired against any substantive post and as such won't confer any right upon the hired persons for regular/permanent appointment.
5. The hired persons shall submit an undertaking in the shape of an affidavit duly attested by Ist Class Magistrate to the effect:
 - i) That in case an adverse report about his/her character and Antecedents, Qualification, Date of Birth, Marks certificates etc, if any is received from the competent authority to whom the references shall be made by the concerned Medical Superintendents, the candidate shall have no right to claim his/her engagement as Jr. Grade Nurse and his/her engagement

- as such shall be deemed to have been cancelled ab-intio. He/she will not also claim for any dues from Govt. Medical College, Srinagar. as well in that case and next candidate as per merit will be considered for engagement as Jr. Grade Nurse.
- ii) That he/she has fully understood the terms, conditions and nature of his/her engagement in Govt. Medical College, Sgr. under National Health Mission Programme will not claim for regularization after completion of the term or at any point of time.
6. The term of contract is extendable by one year beyond expiry of the original contractual term at the discretion of the competent authority, subject to satisfactory performance of duties and:
- a) Availability of Budget/Funds
b) Continuation of such scheme
7. The engagement shall be governed by other terms and conditions, as are not specifically mentioned herein this Order but are made applicable in case of such engagements any time by the contracting authority.
8. The services of the hired persons shall be terminated in case their performance is not satisfactory/upto the mark.
9. Honorarium for one month will be kept as security deposit and will be paid to engage after culmination of the contract and after he/she clears pending dues and returning all assets/other records/items provided to him/her for due performance of his/her duties of such contractual services.
