Whereas, on the basis of marks obtained by the candidates in the written test held on 16.08.2020 and options exercised by them, 14 candidates were engaged as Jr. Grade Nurses on contract basis under National Health Mission (Scheme-A) vide this office Order No: 247 of 2021 dated: 11.01.2021;

Whereas, the candidates so engaged were supposed to join in the offices of Medical Superintendent, L.D Hospital and G.B.Pant Hospital Sgr within a period of 07 days from the date of issuance of the aforesaid engagement Order';

Whereas, the Medical Superintendents, L.D Hospital and Medical Superintendent G.B.Pant Hospital, Sgr. vide their letter Nos. PA/MS/2021/337-342 dated: 21.01.2021 and No: GBP/NHM/4076-81 dated: 21.01.2021 respectively have intimated that out of the 14 candidates, the following three have not joined within the stipulated period of time:

Now therefore it is hereby ordered that:-

- (i) The engagement of the following three candidates as Jr. Grade Nurses on contract basis under National Health Mission Programme (Scheme-A) made vide Order No: 247 of 2021 dated: 11.01.2021 is hereby cancelled abintio:


Terms and Conditions:

1. S.No:01 and 02 shall join in the office of the Medical Superintendent L.D Hospital, Srinagar; whileas, S.No: 03 shall join in the office of the Medical Superintendent G.B.Pant Hospital, within a period of 07 days from the date of issuance of this Order, failing which their engagement shall be deemed to have been cancelled ab-intio without any further notice in this behalf.
2. The engagees shall be allowed to join only on production of the following documents;
 - a. Date of Birth Certificate
 - b. Domicile Certificate
 - c. Diploma/Degree Certificate
 - d. Diploma/Degree Certificate (Year Wise)
 - e. No Loan certificate from District employment Exchange and District Industries Department.
 - f. Any other document as required under rules.
3. The temporary engagement of the above persons is subject to the outcome of the writ petition, if any, pending in the Hon'ble Court of law.
4. The services hired will be purely on temporary basis for a period upto 31.03.2021 or till continuation of the scheme whichever is earlier and will automatically cease/terminate once the scheme is over. It is emphasized that the services are not being hired against any substantive post and as such won't confer any right upon the hired persons for regular/permanent appointment.
5. The hired persons shall submit an undertaking in the shape of an affidavit duly attested by Ist Class Magistrate to the effect:
 - (i) That in case an adverse report about his/her character and Antecedents, Qualification, Date of Birth, Marks certificates etc, if any is received from the competent authority to whom the references shall be made by the concerned Medical



Superintendents, the candidate shall have no right to claim his/her engagement as Jr. Grade Nurse and his/her engagement as such shall be deemed to have been cancelled ab-intio. He/she will not also claim for any dues from Govt. Medical College, Srinagar as well in that case.

- (ii) That he/she has fully understood the terms, conditions and nature of his/her engagement in Govt. Medical College, Sgr. under National Health Mission Programme will not claim for regularization after completion of the term or at any point of time.
6. The term of contract is extendable by one year beyond expiry of the original contractual term at the discretion of the competent authority, subject to satisfactory performance of duties and:
- a) Availability of Budget/Funds.
 - b) Continuation of such scheme.
7. The engagement shall be governed by other terms and conditions, as are not specifically mentioned herein this Order but are made applicable in case of such engagements any time by the contracting authority.
8. The services of the hired persons shall be terminated in case their performance is not satisfactory/up to the mark.
9. Honorarium for one month will be kept as security deposit and will be paid to the engagee after culmination of the contract and after he/she clears pending dues and returns all assets/other records/items provided to him/her for due performance of his/her duties of such contractual services.
