1. Download "Admit Card" from our official website : www.gmcs.edu.in **w.e.f 09.02.2021 (4.30 P.M. onwards).**
2. On the actual date of examination **i.e. 14th February,2021,** the candidates shall report at the respective venues one hour before commencement of examination in each session for the verification of their identity and carry along the Admit Card plus any one of the following documents as proof of their identity :
 - i. Photo ID Card issued by the Competent Authority, or
 - ii. Driving License, or
 - iii. PAN Card/Aadhar Card &
 - iv. one recent passport size photograph.
 - v. a face mask big enough to cover both mouth and nose of the candidate
3. Any type of electronic device, mobile phones, Bluetooth device, earphones books, notebooks, calculators, watches are not allowed inside the venue. Violation, if any, shall be dealt with strictly under law.
4. No Vehicles shall be allowed inside the examination venue.
5. Scrupulously follow the instructions given by Supervisory staff at all the stages of the examination.
6. The Paper shall comprise of (60), multiple choice questions which are to be attempted/completed within one hour.
