The appointment of the above doctor is further subject to Submission of an affidavit duly attested by the Judicial Magistrate/first class Magistrate to the effect that: -

- he will not participate in any kind of strike during the period of his tenure engagement. In the event he proceeds on strike, his

tenure engagement shall be terminated without any notice as this service is covered under ESMA Act.

- b. he shall remain disciplined during the tenure period, any kind of misconduct shall make him liable for termination without any prior notice.
- c. he is not involved in any criminal activity or there is no FIR pending or registered in any criminal department or police station against him.
