The eligible desirous candidates may report for the Walk-in-Interview on the scheduled date and time alongwith the following documents in original and also bring along self attested photocopies of all these documents :

- I. Date of Birth Certificate
- II. MBBS Degree Certificate
- III. Marks sheets of all the examinations passed by the candidate during MBBS course.
- IV. Attempt certificate
- V. Distinction /Honour /Medal/Academic Merit Certificate , if any,
- VI. MCI registration/ J&K Medical Council registration.
- VII. Valid Reserve Category certificate if any.
- VIII. Domicile Certificate issued by the Competent Authority.
- IX. Higher qualification certificate if any
- X. House Job experience in any teaching institution.
- XI. Experience if any.
- XII. Two recent passport size photographs

The candidates possessing qualification of MBBS and above can only participate in the selection process in this phase. In case any vacancy remains unfilled in the first phase then BDS & ISM doctors will be considered for those positions in the 2nd phase for which a separate notification will be issued.

Terms and Conditions of the engagement:-

1. The applicants must be domiciles of UT of Jammu and Kashmir.
2. This contractual engagement won't confer any right upon the hired persons for regular/permanent appointment. The contractual engagees shall have to furnish an affidavit duly attested by the 1st Class Magistrate to the effect that they will not claim for regular appointment at any future date on the strength of this contractual engagement.
3. The engagement will initially be made for one year and will be extended upto three years subject to the satisfactory performance of the candidates/approval of the competent authority and:-
 - a. Availability of Budget/Funds.
 - b. Continuation of this Scheme.
4. The contractual engagees shall be paid full salary corresponding to the minimum of the pay scale including all allowances as long as they remain in the service and actually perform their duties.
5. The contractual engagees shall be entitled to a casual leave of (15) days for the whole period of their contractual engagement of one year. Any leave beyond that period, on whatever ground it may be, shall be at the discretion of the appointing authority on justified grounds.
6. The contractual engagement shall be terminable on one month's notice from either side, or on payment of one month's salary in lieu of notice by the appointing authority; provided that the appointment of the contracting party shall be terminable without notice by the appointing authority whenever the post is filled up on regular basis by it and in that case the contracting party shall have no claim against the Government/appointing authority.
7. The selection committee reserves the right not to fill up the post in case Administrative exigency so demands
8. If a contractual engagee at any point of time willfully neglects or refuses to perform his duties, the appointing authority shall

immediately terminate his/her contractual engagement without any notice and he/she shall not be entitled to any salary for such period.

9. The candidates must be in possession of all required documents and no under process certificate shall be accepted/entertained.
10. If any candidate is already working in any other Medical College as Medical Officer in the UT of Jammu & Kashmir, he/she should get **No Objection Certificate** from the concerned Head of the Institution; otherwise he/she will not be considered for selection.
