Subject:- Conduct of University Examination of MD/MS Students of Government Medical College, Srinagar.

ORDER

The Date Sheet to conduct University Examination of the MD/MS & PG Diploma Course Batch 2017 of Government Medical College, Srinagar has been notified by the University of Kashmir vide endorsement No. F(DateSheet-MD/MS)/KU/2020 Dated 29.05.2020 and the said examination commences from June 15, 2020.

The University statute at 15(7)(c) reads as under:-

“The examination shall be open to a candidate who:-

- c) Has his/her thesis submitted and had approved by the examiners prior to commencement of the written part of the examination.....”

Considering the advisory issued by the Medical Council of India vide letter No. MCI-23(1)/2020-Med./101465 Dated 22/05/2020, wherein they have advised the Universities to complete the University Examinations of PG Broad Specialities by 30th June, 2020, it was imperative to conduct the University examination of the MD/MS & PG Diploma students of the College by 30th June, 2020 in relaxation of the aforementioned clause of the University Statutes.

However, due to COVID-19 pandemic the theses already submitted by the P.G. (MD/MS) students to the University of Kashmir are yet to be evaluated by the concerned Examiners. Since as per the standing University Statutes a P.G. (MD/MS) students is not eligible to sit in the University examination prior to approval of his/her thesis, the P.G. (MD/MS) students appearing in the ensuing University examination shall submit an affidavit (format attached) to the effect that, he/she may be allowed to appear in the University examination, prior to approval of his/her thesis, which is otherwise pre-requisite, purely on his/her own risk and responsibility and in case his/her thesis is not approved by the examiner, his/her examination (university) shall be treated as Null and void.
