Sub:- Notice for cancellation of selection/engagement as Anaesthesia Assistant on academic arrangement under EWS category.

Whereas, subject to scrutiny of the documents and fulfilment of other eligibility parameters, category-wise provisional selection/wait list of the candidates for engagement as Anaesthesia Assistant on academic arrangement basis under SRO 24 of 2019, dated: 10.01.2019 was issued vide this office Notification No. NGS/MC/20/Sel/AA/AAB, Dated:08.08.2020 on the basis of marks obtained by the candidates in the written test held for the purpose on 06.08.2020; and

Whereas, amongst various reserved categories, one candidate namely Ms. Maryam Bano, D/O Ghulam Ahmad Teli, R/O Hazratbal, Srinagar having secured 57 marks in the written test was provisionally selected under EWS category; and

Whereas, after issuance of the provisional selection/waiting list, you submitted a representation in this office on 10.08.2020 whereby you sought inclusion in the final selection list on the ground that you had applied for engagement as Anaesthesia Assistant under EWS category and had scored more marks (67 marks) than Maryam Bano; and

Whereas, on the basis of marks obtained by you in the written test and EWS category certificate attached by you with your application form/ representation, you were included in the final selection list and subsequently engaged as Anaesthesia Assistant on academic arrangement basis under EWS category alongwith other selected candidates vide this office Order No. 95 of 2020 Date 14.08.2020;

Whereas, in the meantime this office received two communications bearing Nos.1250/MM/TEG, dated: 18.08.2020 &

1251/MM/TEG/20, dated: 19.08.2020 from the Tehsildar Eidgah, Srinagar, whereby it has been intimated that EWS Category Certificate issued in your favour has been cancelled vide his office order No. 3671/MM/TEG/19, dated: 09.03.2020 on the basis of re-verification conducted by their field agency;

Whereas, in view of the Tehsildar Eidgah's report you are not eligible to be considered under EWS category and your selection/engagement in that category is to be cancelled ab-initio. However, before doing so an opportunity of being heard is afforded to you to defend your claim/candidate under EWS category;

Now, therefore, through the medium of this notification you are hereby asked to explain your position in the matter by or before 25th August, 2020 with documentary proof, failing which it shall be presumed that you have nothing to say in your defence and the candidate next in merit in the EWS category shall be considered for engagement as Anaesthesia Assistant.
