Whereas, you have joined on 14.08.2018 in the Department of Obsts & Gynae, Government Medical College, Srinagar; and

Whereas, as reported by HOD Obsts & Gynae vide her office letter No. GD/HOD/1687-88 Dated. 17.09.2020 you had applied for (180) days maternity leave w.e.f. 23.08.2019 and was supposed to join back on 19.02.2020; and

Whereas you failed to report back to your duties on 19.02.2020 without any intimation as reported by the HOD Obsts & Gynae vide his aforementioned letter; and
