Advertisement Notice No:- 06 -NGS of 2020

Whereas, this institution conducted a written test on **06.08.2020** for selection/engagement of Anaesthesia Assistant on academic arrangement basis under SRO 24 of 2019, dated: 19.01.2019; and

Whereas, in terms of Govt. Order No. 252-HME of 2012, dated: 26.03.2012 candidates with Diploma/Degree in two streams i.e. Anaesthesia and Operation Theatre Technology were allowed to participate in the selection process;

Whereas, on the basis of marks obtained in the said test, 15 persons were selected for engagement as Anaesthesia Assistant on academic arrangement basis against the available vacancies in the college and its associated hospitals;

Whereas, to meet out the additional manpower for COVID-19, this institution was subsequently authorized to engage 50 more Anaesthesia Technicians under National Health Mission programme for a period of three months or till COVID-19 pandemic is over, whichever is earlier;

Whereas, in order to cut short the time required for making fresh selection, it was decided to utilize the merit obtained by the candidates in the written test held on 06.08.2020 and accordingly vide this office Notification No. NGS/MC/20/AA/NHM/COVID-19 dated 15-10-2020 applications on prescribed format were invited from those candidates who appeared in the said test and are willing to work in this institution under National Health Mission on the terms and conditions elaborated therein;

Whereas, in supersession of all previous orders, the Mission Director, National Health Mission, J&K vide his office Order No. 87 of

2020, dated: 23.10.2020, has fixed the following eligibility criteria for selection/engagement of Anaesthesia Technicians in ICUs and HUDs:

"10+2 with Science or above qualification with Degree in Anaesthesia/Diploma in Anaesthesia Assistant Course from any recognized institute/SMF."

Whereas, the candidates with Degree/Diploma in Anaesthesia have submitted several representations in this office for re-advertisement of the Anaesthesia Technician positions under NHM on the ground that in terms of the above quoted order of MD, NHM, the candidates from Operation Theatre stream are no longer eligible to be considered for engagement as Anaesthesia Technicians under NHM;

Now, therefore, in view of the above stated position, the Notification No. NGS/MC/20/AA/NHM/COVID-19 dated 15-10-2020 is hereby withdrawn and accordingly fresh online applications are invited from the eligible candidates (belonging to Kashmir Division) for filling up of the following positions under National Health Mission Programme to meet out the additional manpower required for COVID-19 initially for a period of period of three months or till COVID-19 is over whichever is earlier.

Terms and conditions

1.	Nature of engagement	Contractual
2.	Period	The contract for hiring shall be for a period of three months or till COVID-19 pandemic is over, whichever is earlier. The contractual hiring shall not confer any right upon the selected candidates to claim regularization/ permanent



		absorption in the institution.
3.	Monthly remuneration	Rs. 12000/= consolidated. P.M. The consolidated remuneration per month is inclusive of all allowances and monetary benefits.
4.	Agreement	The selected candidates shall have to enter into an agreement with this Institution to the effect that they will not leave the job before the completion of three month's term or till continuation of scheme. Abandoning/terminating of the agreement, as the case may be, will require one month's prior notice on either side, failing which the remuneration will not be paid for one month to the incumbent which shall always remain in deposit with the department and shall be released on completion of sanctioned term.
5.	Age	The age of the applicant as on 01.01.2020 must not be above 45 years.

Note : The candidates must be in possession of all required documents and no document/certificate issued beyond the cut off date shall be accepted/entertained.

Instructions for applying online:-

- Candidates are required to apply online through the official website of GMC, Sgr. only.
- The requisite original documents including domicile certificate issued by the competent authority on the format prescribed for the purpose must be produced at the time of document verification, or as and when sought by GMC, Sgr.



- e. The candidates are required to upload the images of their recent photograph and specimen signature which should be uploaded in (Jpeg) format only.
- f. Candidates have to deposit fee of Rs. 300/- through online mode only i.e through Net Banking/Debit Card/Credit Card.
- g. Applications of those candidates will not be considered who do not pay the fee in online mode.
- h. Candidates must take a print out of the application form and fee receipt after successful submission of the online application form.
- i. Candidates can not edit their application form after submission.
- j. Candidates shall ensure that their E-mail ID and Phone Nos. as specified in the online application form are active during the currency of selection process.
