- I. Resolved that the Qadri's College of Medical Laboratory Technology shall be given a notice regarding non- availability of Laboratory slots in different labs of GMC, as the college has started Bsc. MLT course in GMC, Srinagar with the intake capacity of 30 seats per year so the college is not in a position to accommodate the students of Qadri's College. The Head of Department concerned have been directed that till Qadri's College shall make an alternative arrangement, this college shall allow the students of the Qadri's College to complete their internship programme for the year 2022, as per past practice in vogue.
- II. The Medical Superintendents were directed to examine how many MOU's they have undertaken with the Private Para Medical Institutes and inform them that their hospitals have no slots to accommodate students of private para medical college as the intake capacity of AMT school and College of Nursing, GMC, Srinagar has increased manifold.
- III. Resolved that no application whatsoever for internship /observership shall be entertained from any applicant directly.


