WHEREAS; vide Government Order No. 138-JK(HME) of 2022 Dated. 16-03-2022 you were appointed as Lecturer in the Department of Surgery Government Medical College Srinagar and joined in this Office on 17-03-2022;

WHEREAS; vide this Office Order No. 63-GS of 2022 Dated. 18-03-2022 you were posted in the Department of Surgery for further duties;

WHEREAS; vide Endorsement No. HOD/SD/82 Dated. 13-04-2022, the HOD Surgery forwarded your application for permission to undergo two months fellowship programme in China w.e.f. 07-05-2023;


WHEREAS; vide this office letter No: GS-MC/L/Sur/160 dated: 25.04.2013, the HOD Surgery was requested to inform you that you are not entitled to pursue two months fellowship in China in terms of Rule 61(4) (i) of the Jammu and Kashmir Civil Services (Leave) Rules, 1979 notified vide S.O 234 of 2020 dated: 21.07.2020 and instructions issued by the General Administration Department vide: circular No. 49-JK(GAD) of 2022 Dated. 07-12-2022, as you have not completed mandatory service of five years as yet;

WHEREAS; vide letter No. HOD/SD/218 Dated. 13-05-2023 the HOD Surgery informed that you are un-authorizedly absent from your duties w.e.f. 08-05-2023;

WHEREAS; absence from duty without leave or after the end of leave involves loss of appointment in terms of Article 128 of J & K CSRs;

Now, therefore, in light of above, you are hereby directed to resume your duties within a period of (03) days positively and explain your position for remaining on un-authorizedly absent; failing which it shall be presumed that you have nothing to say in your defence and necessary recommendations for initiation of disciplinary action against you as warranted under rules shall be made to the Government (H&ME);
