Pursuant to the selection list issued vide this office No: GS-MC/Sel/Pharmacist/PHC/DRDO/1913-20 dated: 14.09.2021, sanction is hereby accorded to the provisional engagement of Mr. Peerzada Irfan Bashir S/O Peerzada Bashir Ahmad R/O Rednag Lolab Kupwara under Physically Handicapped Category as Pharmacist on contract basis for a period of one year in the pay scale of Level-4 (25500-81100) for the newly established 500 bedded temporary COVID Hospital, Sgr.

The engaged candidate shall report to the Medical Superintendent, (500) bedded temporary COVID Hospital, Sgr. for further duties alongwith the following documents in original within a period of 21 days, failing which his engagement as Pharmacist shall deem to have been cancelled abi-intio:

- a) Date of Birth Certificate
 - b) Domicile Certificate
 - c) Qualification Certificates.
 - d) Diploma/Degree year wise marks certificates.
 - e) No loan certificate from District Employment Exchange and District Industries Department.
 - f) Any other document as required under rules.
- Verification of Character and Antecedents has already been got verified from concerned authorities. (photocopy enclosed).

Terms and conditions of engagement:


- 1) The temporary engagement of the candidate shall be subject to the outcome of the writ petition, if any, pending in the Hon'ble Court of Law.
- 2) This engagement will be purely on temporary basis for a period of one year extendable upto three years subject to satisfactory performance of the candidates/approval of the competent authority and
 - a) Availability of Budget/Funds
 - b) Continuation of such scheme.









- 3) The engagement will automatically cease/terminate once the scheme/period is over whichever is earlier. It is emphasized that the services are not being hired against any substantive post.
- 4) The engaged candidate shall have to submit an undertaking in the shape of an affidavit duly attested by the Ist Class Magistrate to the effect:
 - a) That in case an adverse report about qualification, Date of Birth, Marks Certificates etc, if any, is received from the competent authority to whom the references shall be made by the concerned Medical Superintendent, the candidate shall have no right to claim his/her engagement as Pharmacist and his/her engagement as such shall be deemed to have been cancelled ab-initio. He/she will not also claim for any dues from Govt. Medical College, Srinagar as well.
 - b) That he/she has fully understood the terms, conditions and nature of this contractual engagement and will not claim for regular appointment at any future date on the strength of this contractual engagement.
- 5) The services of the hired person shall be terminated in case his performance is not satisfactory/upto the mark.
- 6) Salary for one month will be kept on hold as security deposit and will be paid to engagee after culmination of the contract and after he/she clears pending dues and returning all assets/other records/items provided to him/her for due performance of his/her duties of such contractual services.
- 7) The contractual engagee shall be paid full salary corresponding to the minimum of the pay scale including all allowances as long as he remain in the service and actually perform his duties.
- 8) The contractual engagee shall be entitled to a casual leave of (15) days for the whole period of his contractual engagement of one year. Any leave beyond that period, on whatever ground it may be, shall be at the discretion of the appointing authority on justified grounds.
- 9) The contractual engagement shall be terminable on one month's notice from either side or on payment of one month's salary in lieu of notice by the appointing authority, provided that the appointment of the



contracting party shall be terminable without notice by the appointing authority whenever the post is filled up on regular basis by it and in that case the contracting party shall have no claim against the Government/Appointing authority.

- 10) If a contractual engagee at any pint of time wilfully neglects or refuses to perform his/her duties, the appointing authority shall immediately terminate his/her contractual appointment without any notice and he/she shall not be entitled to any salary for such period.
