The applicant must have worked as an Associate Professor in the relevant Discipline in NMC/MCI recognized Institute, or as Assistant Professor with following teaching experience:-

- i) *Two years as an Assistant Professor and Two years as Lecturer for those candidates who have worked in (04) tier system.*
- ii) *Four years as an Assistant Professor for those candidates who have worked in (03) tier system directly as Assistant Professor with a minimum of two research original publications in indexed/national journals, accepted/published as first/corresponding author, during the tenure of the Assistant Professor.*

Provided that in case of Research Publications published before 5th June, 2017, first/second author shall also be considered.

For the post of Assistant Professor:-

The applicant must have a minimum of two years teaching/research experience as Registrar/Tutor/Demonstrator or as a Senior Resident after post graduation from an Institution duly recognized/permitted by National Medical Commission.

2-b) Mandatory Teaching experience in respect of serial No. (25):-

For the post of Professor/Medical Superintendent:-

The applicant must have worked as a Professor/Medical Superintendent in the relevant Discipline in a NMC/MCI recognized Institute, or as an Associate Professor/Dy. Medical Superintendent for at least (05) years with four original Research Publications in indexed/national journals, accepted/published as first/corresponding author, out of which minimum two original research publications must have been published during the tenure of the Associate Professor.

Provided that in case of Research Publications published before 5th June, 2017, first/second author shall also be considered.

For the post of Associate Professor/Dy. Medical Superintendent:-

The applicant must have worked as an Associate Professor/Dy. Medical Superintendent in the relevant Discipline in NMC/MCI recognized Institute, or as Assistant Professor/Assistant Medical Superintendent for at least (03) years with two original Research Publications in indexed/national journals, accepted/published as first/corresponding author, out of which minimum two original research publications must have been published during the tenure of the Assistant Professor.


Provided that in case of Research Publications published before 5th June, 2017, first/second author shall also be considered.

For the post of Assistant Professor:-

The applicant must have a minimum of two years teaching/research experience as Registrar or as a Senior Resident after post graduation from an Institution duly recognized/permited by National Medical Commission.

- 3) The maximum age of the applicants at the time of submission of the application forms must not be more than (67) years.
- 4) The appointment against the advertised posts shall always be on Academic arrangement basis only without conferment of any preferential right on the engagees for regular appointment against these posts, which shall be made strictly in accordance with the relevant recruitment rules.
- 5) The appointment on Academic Arrangement basis shall by itself stand terminated on attainment of (70) years of age by the appointee. The services of an appointee under these rules shall be terminable before the expiry of the tenure of appointment with one month's notice from either side or on payment of one month's salary in lieu of notice by the appointing authority. In case of any dispute, the decision of the Chairperson of the selection Committee shall be final.
- 6) The appointees on Academic Arrangement basis shall be paid monthly consolidated salary as per the scales defined in the S.O. 364 of 2020 Dated. 27-11-2020.
- 7) The applicants must have to attach the self-attested Photostat copies of the below mentioned documents, with their application forms:-

 - d) Experience Certificate in the relevant specialty/discipline in a Medical College duly recognized by NMC/MCI.
 - e) Professional Research Publications.
 - f) Proof of writing of book as first or second author (Foreign Book/National Book published with ISBN/ISSN, if any).
 - g) Proof of paper presentation in any National/International seminar/Conference/Workshop relevant to the discipline, if any.
 - h) Proof of Gold Medal for overall first position in prescribed qualification, if any.
 - i) Distinction in sports certified by the Secretary J&K Sports Council, if any.
 - j) Distinction in NCC (Holder of Grade "C" Certificate), if any.
 - k) Two years Registrar/Demonstrator-ship/Tutor/Senior Resident completion certificate.
 - l) Domicile Certificate.

- m) Date of Birth Certificate.
n) An affidavit to the effect that applicant is not on the rolls of any Medical College/Institutions of the Country.
- 8) The applications of those candidates shall be rejected who fail to attach any requisite requirements/documents/marks sheets with their application formats.
- 9) A contact Number must be indicated on the application format.
- 10) The application of Faculty members already working in Medical Colleges of UT on Academic arrangement basis shall be considered only after production of NOC from the respective Head of the Institutions.
- 11) The applications should reach to the office of the Principal/Dean Government Medical College Srinagar (Main Office) by or before **23rd December, 2022 to 15th January, 2023 upto 3:00PM.**
- 12) The applicants shall have to appear before the Selection Committee for interview at Government Medical College, Srinagar alongwith all original testimonials and other related documents on the date which will be notified separately. No T.A/D.A etc. shall be paid to the candidates for attending the Interview.
- 13) The selected candidates shall have to execute an agreement that he/she will not leave the Department before the completion of three year's contract. However abandoning/termination of the arrangement in the Specialty will require one month's prior notice on either side, failing which the salary shall not be paid for one month to the incumbent which shall always remain in deposit with the Department and shall be released on completion of sanctioned term.
- 14) No application of the in-service candidate shall be entertained in terms of **S.O 364 of 2020 Dated. 27-11-2022.**

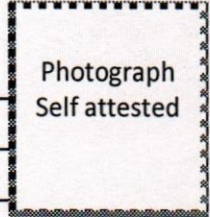
